

# WE ARE THERE FOR THE RETIRED...





# OFFERING SUPPORT TO OVERCOME LIFE'S HURDLES

"Thank you so much for the grant and your successful efforts to coordinate contributions from the other two charities. The treatment that my partner needs after her accident isn't available on the NHS and even with my RN salary we would have been very challenged financially to get what she needs. With the treatment she will be able to get back to her career as a teacher before too long. We will both be forever grateful."

# When I needed support, they were there for me...

"I served as an Officer-Under-Training (Pilot) for just one year over 25 years ago. I did not make it through my training due to illness. Therefore, I was somewhat sceptical when I was told that I might be eligible for support from the RNOC.

Since leaving the Royal Navy, I had a successful career in business for over twenty years. To my shame I made some very foolish life choices and as a result, I found myself imprisoned for 21 months. My imprisonment cost me my career, my family and left me homeless and in serious debt upon release.

At this point, I approached the RNOC and a financial grant was made within a couple of days. This meant that I was able to overcome the hurdle of not having a deposit to get accommodation – and it even covered the costs of some furniture for my new place. Having stable long-term accommodation is the key to my rehabilitation and now I feel that I have a strong platform upon which to try and repair the damage to my life.

Aside from the financial support, the personal and non-judgemental support that the charity has provided me has really restored my faith in humanity and their generosity has been truly humbling."
