I am delighted to report that 2024 was another year the common theme is a vulnerability to unplanned of high achievement by the RNOC with all grant expenditure being met from Investment Income and overall 97% of our expenditure being on charitable purposes which is highly efficient. Annually the amounts spent on each category vary depending on the needs of our beneficiaries. They are diverse in their profiles and situations and the charity responds accordingly.






The Benevolence Committee regularly review caseworkers reports and data from the Rowntree Foundation to consider the levels of grants recommending changes and increases where necessary. We continue, via our annuity scheme (regular payments), to support a number of older veterans and widows with a weekly top up which allows them to maintain a reasonable standard of living. In addition to these regular grants the charity provides one off grants to assist with a wide range of disability and mobility aids. These grants can help restore independence for those who have become isolated or trapped in their own home – sometimes unable to access upper levels or a much-loved garden. For those no longer able to remain at home our assistance with care home fees is greatly appreciated by the individual and other family members. At the RNOC we believe that everyone deserves dignity throughout life, and we have been able to help with end-of-life care and funeral expenses.

Utilising the RNOC Scholarship Fund we are able to ensure that those that need assistance with educational costs are supported. Additionally, while the majority of service personnel make the transition to civilian life very well, the charity is able to offer help with re-training and support with a new career. The number of those serving or approaching end of service asking for help continues to increase. During the past year the charity has offered support with debts, housing costs, the effects of separation, rental fees and support for families to avoid interruption of operational effectiveness.
